17/151 Apologies for Absence

17/156 **Police**

PCSO H Firth was absent but sent a written report as follows:

17/157 **District and County Councillors**

- a) District Councillor Gill Gardner reported that she has been working on arranging hardstanding for parking at Field Head Close.
- b) County Councillor Sue Sanderson was absent but sent a written report:
 - i) She has been busy mainly trying to sort out the responsibilities for Schools and Learning: funding being a particular issue. She attended a weekend training course for elected members with responsibilities for children at the University of Warwick at Coventry, it was hard work but very interesting especially talking to other councillors from different parts of the country. It has also involved visiting a lot of Cumbria she has not been to before.
 - ii) She continues to work with highways about Cartmel and issues relating to Flookburgh. She has devoted most of her members allowance to signage and improving pavements in the playground area and it will still need more funding.
 - iii) She has attended meetings with Highways England re: A590, the developers at Backbarrow Ironworks as a trust needs setting up to maintain the restored Ancient Monument and Newby Bridge garage as Staveley Parish Council are buying a defibrillator and the garage owner is fitting it in the garage.
 - iv) She understands that Lower Holker and Lower Allithwaite Parish Councils have jointly bought a speed gun and she hopes this is working out.

17/158 Planning Applications

The following Planning Applications were considered.

 a) SL/2017/0883.Lakeland Leisure Park Moor Lane Flookburgh LA11 7LT Installation of 85 hardstanding bases (for 85 static caravans) with associated infrastructure (above and below ground), new internal access road, pedestrian footpaths and landscaping.

Resolved To object to this Planning Application for the following reasons:

- The application would result in there being 1127 Properties onsite.
- Speeding traffic continues to be a problem down the access road on Moor Lane.
- The Caravan transportation to and from the site continues disregard the specified times ie between 10 am to 4 pm resulting in school buses and other commuting traffic meeting them.
- The access for a large number of construction vehicles and large caravan transporters through small villages, along the route of the Bay Cycle Way and through the narrow and busy Flookburgh Square (with no pedestrian crossing) is unsuitable.
- The part-time GP Surgery has to cope with an increased demand in the summer months from visitors to the site, reducing the service available to local residents.
- b) SL/2017/0897. 22 Marne Avenue Ravenstown LA11 7LH Single storey rear extension.

Resolved To support this Planning Application as it does not have a negative impact on any neighbouring properties.

c) SL/2017/0810.35 Jutland Avenue Ravenstown LA11 7LF Installation of bay window.

Resolved To support this Planning Application as it does not have a negative impact on any neighbouring properties.

17/159 Planning Decisions

The following Planning Decisions were noted:

- a) SL/2017/0863. 25 Marne Avenue Ravenstown LA11 7LH. Single storey rear extension. Granted.
- b) SL/2017/0750. 2 Willow Lane Flookburgh LA11 7LU. Application for a Lawful Development Certificate (existing) to establish the continuous occupation of the property without complying with the seasonal occupancy condition. Refused.
- c) SL/2017/0794. OS Field No 4978 to rear of Cark Hall Cark-In-Cartmel LA11 7NS Installation of 16 frame mounted photo voltaic solar panels. Granted with conditions relating to planting a copse to the north to screen the panels.

17/160 Financial Reports

- a) **Resolved** The Financial report, including budget comparison and bank reconciliation as at 24 October 2017, was accepted unanimously.
- b) Parish Councillors were asked whether they wanted to suggest items for inclusion in the Parish Council budget 2018/19. Councillor Airey suggested some support for a local individual with severe health problems, however this would be outside the Parish Council's remit.

17/162 **Grant Application**

Great North Air Ambulance have asked whether the Parish Council would support their service which provides emergency response including within the Parish.

Resolved To grant £100 towards the service.

17/163 Highways

The following Highways matters were considered:

a) Road maintenance

Councillors Keith and Rawsthorn raised the issue of the lines not being replaced on the road from Cark to Cartmel following resurfacing making the road dangerous due to vehicles driving in the middle of the road The Clerk has made inquiries about this to Lower Alllithwaite Parish Council but not received a reply.

Resolved To request that Councillor Sanderson to pursue the matter.

- b) Highways matters in process with Cumbria County Council Refer to Councillor Sanderson's report 17/157b.
- c) Overhanging hedges

The Clerk has received a letter from the Market Street residents advising they have cut back the overhanging foliage and will keep it cut back. She has written to thank them. The Clerk has received a letter from Tangerine Group who own Cark Manor advising that they have appointed a new operations manager who will contact the Parish Council about the overhanging hedge/trees once she is in post.

She has not received a response to letters regarding footpath to School Lane or Moor Lane hedges/trees.

d) Parking outside Hair by the Mile.

The Clerk has written to Hair by the Mile, South Lakeland District Council (who granted the original Planning Permission) and Cumbria Highways (who advised on the original Planning Application. No responses have yet been received and vehicles are still parking outside the Hairdressers.

17/164 Consultation

South Lakeland District Council plan to replace the Dog Control Orders which expired in October 2017 with a Public Space Protection Order (PSPO). The PSPO will cover the same criteria and may be expanded to introduce new restrictions regarding fouling and the number of dogs that can be walked by one person.

Resolved To support the Public Space Protection Order and the Clerk to complete the survey on behalf of the Parish Council.

17/165 River Eea – Sewage

The Clerk reported that a site meeting with the Environment Agency and United Utilities has still not taken place. She has reminded the Environment Agency him about this planned meeting and will advise Parish Councillors of the date of this meeting once she has been notified. Councillor Wilson reported that United Utilities are undertaking work lining the sewage pipes between Cark Farm and the Pumping Station in Cark.

17/166 Community Emergency Plan

The Clerk advised that due to printing problems she has not yet distributed the Community Emergency Plan but will do so within the next week.

17/167 New Litter Bin

No response has yet been received.

17/168 **Defibrillator**

The Clerk is still awaiting a price for the exterior box.

17/169 **Speed Gun**

The Speed Gun has been purchased by Lower Allithwaite Parish Council, Lower Holker Parish Council will share the use of this device and are paying half the purchase cost. Training will be required for volunteers and Hi Viz jackets required.

Resolved To contact PCSO H Firth to ask for training to be arranged and to purchase 12 Hi Viz jackets with Speed Monitoring - Lower Holker Parish Council printed on them.

17/170 Public Toilets

17/171 Norman's Seat

Councillor Wilson reported that he will look at Norman's seat in relation to the overgrown trees prior to the next meeting.

17/172 Flookburgh & District Recreational Charity

Councillor Gardner reported that Flookburgh Community Playground is now open. There are still a few additional items to be installed including the Track Ride, Goalposts, trees and signs. The Clerk reported that the site is now insured by the Parish Council, ROSPA have checked and approved the site and bin emptying has been arranged. The Parish Council Budget for next year will include running costs for the Playground, however the Charity should have some funds left to contribute towards costs and will continue to fundraise.

17/173 Clerk's Forum at Derby Arms, Witherslack

The Clerk reported that this will be the last meeting of this Forum due to low attendance. She has found attending these Forums very informative and received useful advice from other Clerks and from the CALC organiser (Amanda McCleery).

17/174 Peninsula Practice Patient Participation Group

A written report has been received from Rhona Barton following Linda Youd's report to the last Parish Council Meeting. She advises that she, Linda and Ann who are the lay members on the PPG had a meeting to talk about "our way forward". They have come up with a plan of action, one of which will be to devise a constitution that applies just to the Flookburgh Surgery. They will also be putting a request into probably December's Parish Link asking for volunteer walk leaders for Flookburgh area. It takes time to get volunteers and more importantly get them trained. They are also devising a flyer to be passed out locally too and are going to contact a few local groups.
